### a. Vermont EPA CPRG application

VT did not get; other NE States submitted consortium grant application w/o VT for 580,000 heat pumps thru incentives.

## b. EVSE program updates

#### i. Awaiting grant agreements for DCFC

Bridgewater Mills (Woodstock) & Red Clover (East Thetford) awarded; 4 ports each; Norwich EV will own in exchange for providing local match; will open in 3 – 4 months once grant agreement executed.

## ii. Struggles with level-2 sites

A couple of applications in the pipeline:

- Copeland backed out; his out-of-pocket match would have been \$4,800; his reason was "no employees need this at this time."
- Thetford Elementary School grant funds reserved; Norwich EV quote too high (\$67,000); Harry has Defiance Electric doing a second quote.
